Program plans were initiated in the summer on the Kaba lithium project in the Georgia lake region of NW Ontario and a sampling program carried out. Highlights of the program results included:

Inaugural mapping and sampling of abundant pegmatite occurrences with mineralized pegmatite containing white micas, garnet and tourmaline. Geochemical analyses show good potential for lithium mineralization with eight samples returning lithium values greater than 50 ppm. Results from this initial sampling program have identified priority pegmatite focus areas for a follow-on site visit, possibly this summer.
